ORDER

On this 28th day of September, 2021, consecutive 4th hearing of Appeal No 112 and 113/2021 was held. Shri Vijay Pertin and Shri Angete Linggi, BDO-cum-PIO Roing, Lower Dibang Valley district were present in the hearing.

The Commission asked Appellant whether he has received informations from the PIO as per the order passed by the Commission in its hearing dated 20th September, 2021. The Appellant informed the Commission that PIO he has not provided informations to him.

The Commission asked the PIO why he failed to comply with the order of the Commission passed on 20th September, 2021. On this the PIO informed the commission that due to communication gape he could not furnish information to the appellant on time.

The Commission seriously viewed the negligence and reluctance shown by the PIO in furnishing informations to the Appellant in time. This Commission in pervious hearings has repeatedly passed directions to the PIO for furnishing of the informations to the Appellant in time and has given ample opportunity to the PIO of being heard.

Now therefore, the Commission imposing penalty of Rs. 25,000/- against the PIO under Sub Section 1 of Section 20 of the RTI Act 2005 for failing of furnishing information within the time specified under Sub Section 1 of Section 7 of the Act of **Appeal No. 112/2021 and 113/2021**. Further the PIO is directed to compensate Rs 5000/- to the Appellant for the monetary losses incurred by him on to and fro journey expenses due to delay in furnishing of informations to Appellant

Further, the PIO is directed to furnish informations to the Appellant on or before next date of hearing on 4th October, 2021 failing to comply with the orders of the Commission, Section 20 (2) of the RTI Act, 2005 shall be invoked against the PIO.

No formal notice be served to both the parties.

Next date of hearing fixed on 4th October, 2021 at 1000 hrs.
