**SUMMON NOTICE**

**Whereas**, Shri Dogra Sargo, filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 19.04.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-115/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 15.02.2021 relating the matter as quoted in Form-A application.

**Whereas**, you, being the Secretary-cum-PIO of Arunachal Pradesh Building & Other Constructions Workers Welfare Board, Itanagar have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

**Whereas**, hearing notice of the Appeal was sent to your through registered AD vide No. EE4038764691N dated 6<sup>th</sup> October, 2021 for your appearance before the Court for hearing on 13<sup>th</sup> October, 2021 but you were found absent during the hearing without giving any intimation to this Court. This vividly reflects that you have willfully avoided the Court and it is a highest negligence of a Public Authority. Moreover, there were no representations from your department to present the case on behalf of you. If you are not the PIO why you havn't forwarded the appeal to the concerned PiO on receipt of the said appeal within 05(five) days under **sub-section (1) of section 19 of RTI Act-2005**, forwarding of application may be done with information to concerned applicant invariably.

**Therefore**, you are hereby directed to appear in person before the Hon'ble Commission (Arunachal Pradesh Information Commission) for hearing on **3<sup>rd</sup> November, 2021 at 1030 hrs** alongwith the informations sought by the Appellant, failing which, matter will be heard and determined ex-parte and Sub Section 1 of Section 20 of the Act shall be invoked against you.
