## ORDER

The Appellant vide his RTI application dated 17.02.2021 sought information on 20 points as contained therein.

The PIO did not provide any reply to the Appellant in response to the present RTI application. The Appellant then filed a First Appeal. The First Appellate Authority vide order dated 09.04.2021 directed the PIO to furnish the information to the Appellant within 15 days from the date of the issue of order.

The Appellant thereafter filed a second appeal before the commission with a request to provide complete information.

Hearing of the Second Appeal was heard on 24.09.2021. The PIO remained absent. The Appellant was present during the hearing. The commission after hearing the Appellant and after perusing the case records directed the PIO to furnish correct and complete information to the Appellant. Compliance report was to be sent to the commission before 16.10.2021.

Today is the second hearing of the Appeal. The PIO is again absent today. The commission after considering the submissions of the Appellant and perusal of records, notes that the PIO deliberately did not respond to the summon issued on 05.05.2021 and the commission's order dated 24.09.2021. While taking very strong exception of the non-attendance of the PIO during the hearing and also the deliberate delay in furnishing the information, the commission hereby directs the PIO to furnish complete and correct information to the Appellant before 29.10.2021 with a copy marked to the commission as action taken report, failing which action under section 20 (1) of the RTI Act, 2005, shall be taken by the commission.

Hearing is adjourned to **05.11.2021 at 1030 hrs.** The PIO is directed to be present during the hearing.

Copy of this order be supplied to both the PIO and the Appellant.
