ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Amin Danggen, Village-Simong, Po/Ps Yingkiong, Upper Siang District, Arunachal Pradesh, for non-furnishing of information, by The PIO-cum-DDSE, O/o DDSE, Near DC Office Yingkiong, Upper Siang District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 05/08/2019.

Whereas, the 1st hearing was held through online video / audio conference on 10th November'2020. Shri Nakyam Tasing, the PIO-cum-DDSE, O/o DDSE, Near DC Office Yingkiong, Upper Siang District, Arunachal Pradesh, appeared in the hearing through online video conferencing and the Appellant Shri Amin Danggen attended the hearing through online audio conferencing. The PIO informed the Commission that he has taken over the Charge of The PIO-cum-DDSE Yingkiong in the month of December'2019. The information was sought on 5th August'2020 and also the APIO did not bring the matter before the notice of the PIO. However, after receiving the summon from the Commission the PIO has kept all the information ready to be given to the Appellant. The PIO also asked the Appellant to be specific in seeking information as the information sought at Sl.no. 4 of the Form A is clumsy.

Whereas, the Commission directed the PIO to furnish all the correct, complete and authenticated information as sought by the Appellant in the Form A to the Appellant within ten days from the date of issue of this order free of cost. The Commission also directed the PIO to give in writing for the information which are not available in the office record. The Commission asked the Appellant to collect the information from the office of the PIO-cum-DDSE, Yingkiong latest by 17th November'2020. The Commission also asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held through online video / audio conference on 24th November'2020. Shri Nakyam Tasing, the PIO-cum-DDSE, O/o DDSE, Near DC Office Yingkiong, Upper Siang District, Arunachal Pradesh, and the Appellant Shri Amin Danggen appeared in the hearing through online video conferencing. The Appellant informed the Commission that the PIO has not furnished complete information for **Sl.no. 1** i.e. the details of infrastructure i.e. School Building, staff, qtrs., playground, furniture etc with photograph; **Sl.no. 3** i.e. School wise detail of govt. **schemes, projects, maintenance works** and infrastructure development executed / provided by Govt. (state or central) and **Sl.no. 5** i.e. whether any govt defunct schools have been handed over to any organisation, department, NGOs etc. The Appellant also informed that he is satisfied with rest of the information furnished by the PIO. The PIO appealed the Commission to **exempt photographs of schools** as there are total no. of **one hundred four schools** spread over the district, and no such photographs are being maintained. The PIO also appealed the Commission to give one month time to collect information from various schools in the district and furnish the information to the Appellant.

Whereas, the Commission after hearing both the parties asked the Appellant to exempt photographs of schools and directed the PIO to furnish information for the **Sl.no. 1** i.e. the details of infrastructure i.e. School Building, staff, qtrs., playground, furniture; **Sl.no. 3** Govt. schemes, project against each school if any and for **Sl.no. 5** give in writing to the Appellant in details on or before 20th December'2020. The Commission also asked the Appellant to receive the information go through and convey his satisfaction or dissatisfaction before next date of hearing.

The next date of hearing is fixed on 5th January ²⁰²¹~~2020~~ at 10:30 hrs.

Therefore, **Shri Nakyam Tasing, the PIO-cum-DDSE, O/o DDSE, Near DC Office Yingkiong, Upper Siang District, Arunachal Pradesh**, is hereby summoned to appear before this Court **in person** on the scheduled date and time without fail.


