**ORDER**

**Whereas, the 1<sup>st</sup> hearing was held on 2<sup>rd</sup> March' 2021.** Shri Chukhu Loma, SFS, PIO-cum-DFO, Bomdila Forest Division, Bomdila, Arunachal Pradesh, was found absent during the hearing.
