Activity Code (21532301) C/o Water Tank Focus Area Drinking Water amounting to Rs. 8,86,833/- (Eight Lakh Eighty Six Thousand Eight Hundred Thirty Three) only. Activity Code (21530031) amounting to Rs. 22,14,225 (Twenty Two Lakh Fourteen Thousand Two Hundred Twenty Five) only for C/o footpath focus area roads under Sangram-Punrung-II (102568).

Whereas, the Commission is satisfied that there are reasonable grounds to hear and dispose of the said appeal under the provisions of Rights to Information Act, 2005.
