## ORDER

The Appellant vide his RTI application dated 02.03.2021 sought information on 2 points as contained therein.

The PIO did not provide any reply to the Appellant in response to the present RTI application. The Appellant then filed a First Appeal. The First Appellate Authority also did not responded to the appeal.

The Appellant, thereafter, filed a second appeal before the commission with a request to provide complete information.

Hearing of the second Appeal was taken up on 24.09.2021. The appellant was present. Mr T. Wodie, JE appeared on behalf of the PIO.

Mr. T Wodie appearing on behalf of the PIO informed the commission that the PIO vide letter dated 20.09.2021 had already furnished the information to the appellant. The appellant in his response stated that no such communication was received by him. He has, however, agreed to collect the information but sought time for verification of the information. The appellant was directed to report to commission in case he finds any deficiency in the information so furnished by the PIO. The hearing was, accordingly, adjourned to 22.10.2021.

The matter was again heard on 22.10.2021. The Appellant was present. The PIO was again absent. During the course of hearing the appellant submitted that information furnished by the PIO is incomplete. According to the appellant, there are two separate packages, but the PIO furnished common DPR and payment details. He, therefore, demanded that the PIO to furnish separate DPR and payment details for the two packages.

The commission, after due consideration of the submission made by the Appellant, directed the PIO to furnish DPR and payment details for package No. AR-06/02002 and AR-06/02/003 separately by 29.10.2021.

Today is 3<sup>rd</sup> hearing of this Appeal. The Appellant is present while the PIO is absent.

The Appellant, who is present during the hearing, has submitted that the PIO has furnished the information as per the direction of the commission. He has however, stated that information relating to DPR is incomplete. As according to the Appellant, DPR should normally contain drawing/map of the structure etc, but same are missing.

The commission after hearing the submissions made by the Appellant directs the PIO to furnish correct and complete DPR of the project before next date of hearing.

The hearing is adjourned to 26.11.2021 at 10:30 hrs.

**The Appellant is directed to furnish the copy of this order to the PIO.**
