ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, President Siang Rights Forum(SRF), Airfield Pasighat, Ward No-4, Po/Ps-Pasighat, East Siang District, for non-furnishing of information, by Shri Gonong Pertin, PIO-cum-EE(WRD), Pasighat Division, East Siang District , Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 27/07/2020 regarding Anti Erosion Flood Protection works on the bank of Siang river at Mebo side.

Whereas, the 1<sup>st</sup> hearing was held through online video / audio conference on 15<sup>th</sup> December'2020. Shri Gonong Pertin, PIO-cum-EE(WRD), Pasighat Division, East Siang District , Arunachal Pradesh, and the Appellant Shri Soney Pertin appeared in the hearing thorough on line video conferencing. The Appellant informed the Commission that he has received all the information except for the **Sl.no. 5. i.e. Furnish the copy of colouring photograph before and after execution of the work site.** The PIO informed that in the record the information sought is not available so could not be furnished to the Appellant.

The Commission directed the PIO to have site inspection on 27<sup>th</sup> December'2020. The next date of hearing is fixed on 2<sup>nd</sup> February' 2021 at 10:30 hrs.
