SUMMON NOTICE

Whereas, Smt. Yayi Lendo Jomoh & Shri Jikke Tayu, filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 21.06.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-159/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of their application dated 23.02.2021 relating the matter as quoted in Form-A application.

Whereas, you, being PIO-cum-Director(SJETA)Itanagar, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, hearing notice of the Appeal was sent to you through registered AD vide No. EE408742530IN dated 7th October, 2021 for your appearance before the Court for hearing on 20th October, 2021 but you were found absent during the hearing without giving any intimation to this Court.

Therefore, you are hereby directed to appear in person before the Hon'ble Commission of APIC (Arunachal Pradesh Information Commission) for hearing on **17th November, 2021 at 1030 hrs for Audi alteram partem** alongwith the informations sought by the Appellant, failing which, matter will be heard and determined ex-parte and Sub Section 1 of Section 20 of the RTI Act, 2005 shall be invoked against you.
