ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 was received from **Shri David Jebisow, C/o Adv. Ajay Regisow, Session Court Bomdila, Arunachal Pradesh.** for non-furnishing of information, by **Shri Chuku Loma, SFS, PIO-Cum-DFO, Bomdila Forest Division, Bomdila, Arunachal Pradesh.** as sought for by the Appellant under section 6(1) of RTI Act, 2005. **regarding C/o-Raising of tall Avenue plant(1.5 mtre) with bomboo guard at 5 mtr spacing at kimi**

Whereas, the 1st hearing was held on 2nd march 2021. The appellant Shri David Jebisow and the Advocate Ajay Regisow were present. The Advocate informed the commission that no information had been furnished. Shri Chukhu Loma, PIO-cum-DFO, Bomdila was found absent during hearing. However he attended the hearing through online Audio conferencing and informed the commission that the informations were ready to be furnished to the appellant.

Whereas, today is 2nd hearing of this appeal before the commission. The Appellant Shri David Jebisow is absent. PIO-cum-DFO, Shri Chukhu Loma is present during the hearing.

Whereas, PIO-cum DFO, Shri Chukhu Loma has informed the commission that the requested information was furnished to the Appellant on 11 March 2021. But the Appellant Shri David Jebisow, submitted an application on 22nd March, 2021 informing the commission that information furnished by the PIO-cum DFO was found to be incorrect, incomplete and misleading. And therefore, he is not satisfied with the information furnished by the PIO.

In view of the above the case is adjourned and posted for next hearing on 7th May, 2021 at 10:30 hrs.

The PIO-cum DFO SFS shall again be present before the commission on schedule date and time along with all documents including photograph, geo-tech photograph (geo co-ordinate) in original.
