ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Dana Takuk, S/o Shri Takar Takuk, Village Ngopok, Mebo, P.O. Mebo & P.S. Pasighat, District East Siang, Arunachal Pradesh, for non-furnishing of information, by Shri Tashi Mize, PIO-cum-DFO, Pasighat Forest Division, Pasighat, District East Siang, Arunachal Pradesh, as sought, by the Appellants under section 6(1) of RTI Act, 2005 on 03/07/2020, regarding on going various schemes in Pasighat Forest Division.

Whereas, the 1st hearing was held on 19th January'2021. Shri Tashi Mize, PIO-cum-DFO, Pasighat Forest Division, Pasighat, District East Siang, Arunachal Pradesh and the Appellant Shri Dana Takuk were found absent. However, the PIO was represented by Shri Tatok Tapok, Asstt, O/o DFO Pasighat Forest Division, Pasighat authorized vide letter No. PFD/28/HA/2013/RTI/14-15 Dated Pasighat, the 18/01/21 and the Adv. Yagam Panyeng represented the Appellant. Shri Tatok Tapok, informed the Commission that he had personally met the said Appellant Shri Dana Takuk on 18th January'2021 and had requested him to accompany him for the hearing in his vehicle. But, the said Appellant Shri Dana Takuk informed him that he had never signed any RTI Application or applied any application for any information. Shri Tatok Tapok also informed that the said Appellant has stated that it is a forgery case as the application has been applied without the knowledge and consent of him. The said representative of the Appellant, Adv. Yagam Panyeng represented the Appellant without any **Vakalatnama / authorization** letter and preparation. There is also every reason to doubt how can Shri Dana Takuk a BPL card holder can afford to hire an advocate when there is adequate provision under this Act to persuade the case by himself.

Whereas, the Commission taking note of the statement of Shri Tatok Tapok, Asstt. O/o DFO Pasighat Forest Division, Pasighat directed him to collect contact no. of the Appellant and furnish it to the Commission. The Commission also asked the Advocate to inform the Appellant that in the next date of hearing, the Appellant Shri Dana Takuk should attend the hearing in person, failing which the case shall be disposed of.

The next date of hearing is fixed on 9th February' 2021 at 10:30 hrs.

Therefore, **Shri Tashi Mize, PIO-cum-DFO, Pasighat Forest Division, Pasighat, District East Siang, Arunachal Pradesh**, is hereby summoned to appear before this Court **in person** on the scheduled date and time without fail.
