**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Margam Ori, C/o Eastern Horizon & Offset Printing press, T.T.Marg, Bank Tinali, Itanagar, Arunachal Pradesh, for non-furnishing of information, by Shri Talom Dupak, The PIO-cum-ADC, Capital Complex, Itanagar, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 29/06/2020, regarding Eviction of encroachment of Govt. quarters/ Public premises.

Whereas, the 1<sup>st</sup> hearing was held on 9<sup>th</sup> February' 2021 at 10.30 Hrs before the Hon'ble Court of Dr. Joram Begi, State Chief Information Commissioner, Shri Talom Dupak, The PIO-cum-ADC, Capital Complex, Itanagar was found absent during the hearing. The Appellant, Shri Margam Ori, was present. Shri Tem Kaya, DACO- cum- APIO & Shri Igo Riba, (DA-RTI), Office of the Deputy Commissioner Capital Regional Itanagar represented the PIO. The Appellant, Shri Margam Ori, informed the Commission that the PIO has furnished only information for Sl.no. iv, as sought at Form-A. The APIO, informed that due COVID-19 pandemic and Panchayat election all the Officers and officials were engaged in the field duty, consequently the information as sought by the appellant could not be furnished within the prescribed time period. The APIO sought time for furnishing of information to the Appellant.



Whereas, the Commission hearing the arguments of both the parties and going through the details of information sought by the Appellant in the Form-A, found lacunae's in the functioning of the Capital Complex administration in respect of accountability of Government quarters. The Commission with a caution directed the PIO to furnish complete, correct and authenticated information for **Sl.no. i,ii,iii,v & vi** as sought at Form-A, to the Appellant within nineteen days from the date of issue of this order. Failing which u/s 20(1) of the RTI Act 2005 penalty of Rs. 25, 000/- (Rupees twenty five thousand) only shall be imposed on the PIO in the next date of hearing. The Commission asked the Appellant to receive the information go through and convey his satisfaction or dissatisfaction in the next date of hearing.

**Whereas, the 2<sup>nd</sup> hearing was held on 9<sup>th</sup> March' 2021 at 10.30.** Shri Talom Dupak, The PIO-cum-ADC, Capital Complex, Itanagar was found absent during the hearing. The Appellant, Shri Margam Ori, was present. Shri Tem Kaya, DACO- cum- APIO, Office of the Deputy Commissioner Capital Region, Itanagar represented the PIO. The APIO informed that the information were kept ready and they had tried to contact the Appellant but could not be contacted even through mobile phone. So, the APIO brought the information in the court during the hearing. The Appellant received the information and appealed the Commission to give time to go through it.

**Whereas,** the Commission, in view of appeal of the Appellant giving reasonable time to go through the information asked the Appellant to go through the information furnished by the PIO also seek remaining information if any left out and convey his satisfaction or dissatisfaction in the next date of hearing.

**The next date of hearing is fixed on 23<sup>rd</sup> March' 2021 at 10:30 hrs.**

Therefore, **Shri Talom Dupak, The PIO-cum-ADC, Capital Complex, Itanagar,** is hereby summoned to appear before this Court **in person** on the scheduled date and time without fail.
