**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Dana Takuk, S/o Shri Takar Takuk, Village Ngopok, Mebo, P.O. Mebo & P.S. Pasighat, District East Siang, Arunachal Pradesh, for non-furnishing of information, by Shri Ojing Nangkar, PIO-cum-DLRSO, Pasighat, East Siang District, Arunachal Pradesh, as sought, by the Appellants under section 6(1) of RTI Act, 2005 on 02/07/2020, regarding inspection of files & records of Pasighat Township Land.

**Whereas, the 1<sup>st</sup> hearing was held on 9<sup>th</sup> February' 2021.** Shri Ojing Nangkar, PIO-cum-DLRSO, Pasighat, East Siang District, Arunachal Pradesh and the Appellant Shri Dana Takuk were found absent during the hearing. However, the PIO was represented by Advocate Kaling Mengu (Standing Counsel Land Management) authorized vide Order No. ESD/LM/RTI/2020(Pt)/ 1072 Dated Pasighat the 2/02/2021.

**Whereas,** the Commission while hearing the case APIC-171/2020 (Appeal) found that the same Appellant Shri Dana Takuk, S/o Shri TakarTakuk, Village Ngopok, Mebo, P.O. Mebo & P.S. Pasighat, District East Siang, Arunachal Pradesh, actually did not file the application by himself and as such, the cases no. APIC-170/2020 and APIC-171/2020 have been dismissed by the Commission. Therefore, the Commission giving reasonable opportunity to the Applicant summon him to attend the next hearing in person and establish the fact that he actually filed the application by himself, failing which the case shall stand dismissed.



The next date of hearing is fixed on 16<sup>th</sup> March' 2021 at 10:30 hrs.


