The PIO who is also present during the hearing, has stated that information sought in point no. (iv) and (v) of the application cannot be furnished as it is exempted from disclosure under section 8 (1) (d) and section 9 of the RTI Act.

Mr A Tatak learned Advocate appearing on behalf of the proprietor M/s. I.B Enterprise, Aalo has informed the commission that copy of the 2nd appeal has not been supplied to the proprietor of M/s. I.B Enterprise and has requested the commission to furnish a copy of the same. He has also requested the commission to give an opportunity of being heard to the proprietor of M/s. I.B Enterprises.

The commission has considered the request of learned Advocate Shri A Tatak to give opportunity of hearing to the Third Party. Accordingly, notice shall be issued to the Third Party.

Hearing is adjourned to 17th December, 2021. The PIO and the Appellant are directed to be present during next hearing. No formal order be issued to the parties.
