SUMMON NOTICE

Whereas, Shri Torang Nokbi filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 06.09.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-231/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 02.06.2021 relating the matter as quoted in Form-A application.

Whereas, you, being PIO-cum-Executive Engineer (UD & Housing), District Tirap, Khonsa Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, hearing notice of the Appeal was sent to your through registered AD vide No. EE408737883IN dated 21st September, 2021 for your appearance before the Court for hearing on 28th September, 2021 but you were found absent during the hearing without giving any intimation to this Court.

Therefore, you are hereby directed to appear in person before the Commission (APIC) for hearing on 25th October, 2021 at 1000 hrs failing which, matter will be heard and determined ex-parte and Sub Section 1 of Section 20 of the Act shall be invoked against you.


