SECOND SUMMON NOTICE

Whereas, Shri KL Nayam & Libi Marde filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 08.09.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-233/2021, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 08.04.2021 relating the matter as quoted in Form-A application.

Whereas, you, being District Panchayat Development Officer of District: Longding, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, summon notice was served to you on 30th September, 2021 vide Memo No. APIC-233/2021 2021/714 for your personal appearance before the Court for hearing on 4th October, 2021 but you were found absent consecutively twice during the hearing without giving any intimation or reasons of absence to this Court.

Therefore, final summon notice is being served to you for personal appearance before the Commission (APIC) for 3rd hearing on 26th October, 2021 at 1000 hrs alongwith informations sought by the Appellant, failing which Section 20 (1) & (2) of the RTI Act, 2005 shall be invoked against you.
