6. The authorised representative of the PIO/Appellant/Complainant/Third party is advised to carry a proof of identity along with the authorisation letter.

7. Take notice that in default of your appearance on the time and date mentioned aforesaid the case shall be heard and decided in your absence and that there will no adjournment and review.
