ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Getem Gamno, Roing, Lower Dibang Valley District, Arunachal Pradesh, for non-furnishing of information by Shri O.Lego, PIO-cum-Project Director, DRDA, Roing, Lower Dibang Valley District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 01/10/2020 regarding MGNREGA.

Whereas, the 1st hearing was held on 9th March' 2021. Shri Oling Lego, PIO-cum-Project Director, DRDA, Roing, Lower Dibang Valley District, Arunachal Pradesh was present during the hearing. The Appellant Shri Getem Gamno was found absent, however the Appellant was represented by Shri Tanibar Jerang. The representative of the Appellant informed that no information has been furnished by the PIO. The PIO informed that due to communication gap, misunderstanding with the Appellant and leave of Shri N.S. Kushwa, APIO-cum-APO on medical ground the information could not be furnished to the Appellant within prescribed time. However, the PIO brought some information during the hearing and appealed the Commission to give some reasonable time to furnish all the information as sought by the Appellant.

Whereas, the Commission giving reasonable opportunity to the PIO directed him to furnish complete, correct and authenticated information to the Appellant free of cost within fifteen days from the date of issue of this order, failing which Section 20(1) of the RTI Act 2005 shall be invoked against the PIO in the next hearing. The Appellant is also asked to receive the information, go through and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 6th April' 2021 at 10:30 hrs.

Therefore, **Shri Oling Lego, PIO-cum-Project Director, DRDA, Roing, Lower Dibang Valley District, Arunachal Pradesh**, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
