1. Providing water supply in and around Amount.
2. Renovation of WTP of Mebo water supply project (SH: repairing of various Tank replacement of filter media maintainance of approach road C/O supporting pillar etc).
3. Renovation of existing WTP of Pasighat Township.
4. Providing mater Supply to leying and lirim area.
5. Replacement and relaying of distribution network of Mebo Romdum Darne and Mebo Township.
