ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Geken Boje, F-Sector, Arunachal Pradesh, Itanagar, for non-furnishing of information by Ms. Sumedha Yadav, PIO-cum-Joint Secretary, Science & Technology, Block-IV, 2nd Floor, Room No. 6. Civil Sectt, Itanagar, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 04/11/2020 regarding Photo copy of note sheet correspondence of the File No. Secy.(S&T)/16/17-18 Dated 19th June' 2017.

Whereas, the 1st hearing was held on 9th March' 2021. Ms. Sumedha Yadav, PIO-cum-Joint Secretary, Science & Technology, was present during the hearing. Shri Geken Boje attended the hearing telephonically. The PIO informed the Commission that the information sought is under the jurisdiction and custody of the Directorate of Science & Technology. The Application of the Appellant has been forwarded to the PIO of the Directorate of Science & Technology and Appellant was also asked to approach the concern Public Information Officer, Department of Science & Technology.

Whereas, the Commission, made it clear that the application for information, that is, **photo copy of (both note sheet & correspondence) of File No. Secy. (S&T)/16/17-18 Dated 19th June 2017** has been made by the Appellant to the PIO of the Secretary, Science & Technology, Govt. of A.P. and the said file belongs to the Secretariat, not of the Directorate. As such, Ms. Sumedha Yadav, PIO-cum-Joint Secretary, Science & Technology, is directed to furnish the information with her authentication, within ten days from the date of issue of this order by calling back the file, even if the file is under the custody of the Directorate / State Council of Science & Technology, Govt. of A.P. It is also to be noted that if the order is not complied with, the Commission may be compelled to invoke section 20 of the RTI Act 2005. The Commission also asked the Appellant to receive the information go through and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 23rd March' 2021 at 10:30 hrs.
