ORDER

This appeal has been filed under section 19(3) of the RTI, Act, 2005 by Shri Kumar Tayem, Kongno Village, Chimpu, Itanagar against Asstt. Surveyor Work-Cum-PIO Engg Wing, Dept of Education, Itanagar. Brief facts of the case is that the appellant submitted the application in form 'A' to the Asstt. surveyor Work-cum-PIO on 24th, Nov, 2020, wherein the appellant sought some information about the work undertaken by the Deptt. c/o the "establishment of model residential school at Linia, Lower Subansiri Dist, A.P ". The PIO has furnished only the information sought in Sl.No.(b),(c)(g) and (h) of the application and refused to furnish the rest of the information. Aggrieved by the decision of the PIO, an appeal was filed to the Director-cum-First Appellate Authority of the Education Deptt, Itanagar. No response was received from the First Appellate also. And the appellant, having received no relief from the First Appellate Authority, has filed this appeal before the commission.

The commission has admitted the appeal and accordingly served notice to both the parties. Both PIO and the appellant present. Heard both appellant and the PIO.

The appellant has admitted to have received only the information in Sl. No. (b),(c),(g) and (h) of his information, but rest of the information has been denied to him. He has, therefore, requested that rest of the information should also be furnished to him as it is not exempted under section 8 of the Act. During the course of hearing the PIO has informed that all the information except those mentioned in Sl.No. (a) and (i) of the application are available with him and are already to be furnished to the appellant. The appellant has agreed to receive the information, but sought time for verification. The commission has agreed to the request made by the

appellant and asked the appellant to report to the commission immediately after proper verification of the information so furnished by the PIO.

Next date of hearing is fixed on 4th June, 2021. No formal notice be issued.
