**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Tania June, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-District Veterinary Officer, Deptt of AH/Vety and DD, Govt. of A.P., Lower Subansiri District, Ziro, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 18/10/2021 regarding M/s Ziro Valley Milk Producer Co-op Society Ltd, Ziro.

**Whereas, the rescheduled 1<sup>st</sup> hearing was held on 22<sup>nd</sup> March' 2022 at 1030hrs.** The PIO-cum-District Veterinary Officer, Deptt of AH/Vety and DD, Govt. of A.P., Lower Subansiri District, Ziro, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that the PIO has not furnished any information as sought by him.

**Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty.** As the PIO was absent during the hearing, the Commission could not hear from him. So, the Commission giving a reasonable opportunity to the PIO, decided to fix next date of hearing. If the PIO is found absent in the next date of hearing, the Commission may be compelled to impose penalty under section 20(1) of the RTI Act 2005 on the PIO.

The next date of hearing is fixed on 31<sup>st</sup> May '2022 at 10:30 hrs.

Therefore, The PIO-cum-District Veterinary Officer, Deptt of AH/Vety and DD, Govt. of A.P., Lower Subansiri District, Ziro, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
