ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, President (AAVS), & Shri Likha Tassar GS(AAVS), C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-Superintending Engineer(PWD), Yachuli, Ziro II 16th Yachuli, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 18/10/2021 regarding appointment of UDC, LDC, Peon, Chowkidar, Sweeper Driver, and MTS under establishment of PWD Yazali Division, Ziro II Lower Subansiri District.

Whereas, the rescheduled 1st hearing was held on 22nd March' 2022 at 1030hrs. The PIO-cum-Superintending Engineer (PWD), Yachuli, Ziro II 16th Yachuli, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that the PIO has not furnished any information as sought by him.

Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty. As the PIO was absent during the hearing, the Commission could not hear from him. So, the Commission giving a reasonable opportunity to the PIO, decided to fix next date of hearing. If the PIO is found absent in the next date of hearing, the Commission may be compelled to impose penalty under section 20(1) of the RTI Act 2005 on the PIO.

Whereas, the 2nd hearing was held on 31st May '2022 at 1030hrs. The PIO-cum-Superintending Engineer (PWD), Yachuli, Ziro II 16th Yachuli, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that the information has been delivered at the correspondence address Chandini Hotel, Naharlagun as provided by the Appellant. The Appellant informed that he will receive information from the address and convey his satisfaction or dissatisfaction to the PIO and the Commission.

Whereas, the Commission giving reasonable opportunity to the Appellant to receive the information and to go through the information, the Commission decided to fix one more date of hearing.

The next date of hearing is fixed on 2nd August'2022 at 10:30 hrs.

Therefore, the PIO-cum-Superintending Engineer (PWD), Yachuli, Ziro II 16th Yachuli, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
