<u>ORDER</u>

The appellant vide his RTI application dated 08.11.2021 sought information on 07 points as contained therein. The PIO did not provide any reply to the appellant in response to the present RTI application. The appellant then filed a first appeal. The FAA also did not response to the appeal. The appellant thereafter, filed a second appeal before the commission with a request to provide complete information.

The appeal is heard today. The appellant Abang Yangfo is present. PIO-cum-DC, O/o the Deputy Commissioner, Seppa, East Kameng is absent.

I have heard the appellant.

In his submission to the commission, the appellant has stated that he has not received any response either from the PIO or from the FAA. He has, therefore, requested the commission to pass an appropriate order directing the PIO to provide the information at the earliest.

The commission, after hearing the submission made by the appellant, notes that in the absence of sufficient materials it cannot be concluded that the FAA or the PIO has failed to take appropriate action to furnish the information to the appellant. The PIO is also not present to contest the submission of the appellant. With this, the commission opines that in such a situation the hearing of the appeal should be adjourned. Therefore, the hearing is adjourned to July 08, 2022.

The PIO is directed to appear in person during the hearing on the above mentioned date.
