## ORDER

Vs

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, O/o Deputy Commissioner, Govt. of A.P., Jamin, Kra Dadi District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 08/11/2021 regarding Detail expenditure of Deputy Commissioner untied fund.

Whereas, the 1<sup>st</sup> hearing was held on 15<sup>th</sup> March'2022 at 1030hrs as scheduled. Shri Biri Tako, the PIO-cum-DPO, O/o Deputy Commissioner, Govt. of A.P., Jamin, Kra Dadi District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that the RTI Application From-A Dated 08/11/2021 of the Appellant was received by his office on 6/12/2021. On 10 /12/2021 the Appellant was intimated that the information sought for were ready and collect the same after depositing the fee required through Treasury challan. The PIO further informed the Commission that when there was no response from the appellant, same was intimated through whatsApp too. Inspite of various efforts the Appellant neither responded to the intimation nor turned up for collection of the information sought for by the Appellant.

Whereas, the Commission after hearing the PIO and on going through the the intimation letter and WhatsApp clips of intimation, directed the Appellant to deposit the required fee for the information and collect the same from the office of the concerned PIO. The Appellant agreed to comply with the commissioner's direction. The Commission also asked the Appellant to go through the information and to convey about his satisfaction or dissatisfaction on the next date of hearing.

The next date of hearing is fixed on 10th May, 2022 at 10:30 hrs.
