Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE (PWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding implementation of schemes and Fund Sanctioned under, SADA, SIDF, RE, PMGSY, (State Annual Development Agenda) 2014 to 2021.

Whereas, the 1st hearing was held on 15th March'2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The appellant informed the Commission that the PIO has not furnished any information as sought by him.
