ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE (PWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding implementation of schemes and Fund Sanctioned under, SADA, SIDF, RE, PMGSY, (State Annual Development Agenda) 2014 to 2021.

Whereas, the 1st hearing was held on 15th March'2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The appellant informed the Commission that the PIO has not furnished any information as sought by him. The PIO informed that he has joined the present posting in the month of October'2021 and the RTI Application Form- A was received on 27th October, 2021. Since, the information sought is voluminous, new to the present PIO and shortages of staff, the information could not be furnished to the Appellant on time. The PIO agreed to comply with the directions of the commission. The Commission also asked the Appellant to receive the information from the PIO's office and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 10th May, 2022 at 10:30 hrs.
