**ORDER**

**Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE (PWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding implementation of schemes and Fund Sanctioned under, SADA, SIDF, RE, PMGSY, (State Annual Development Agenda) 2014 to 2021.**

**Whereas, the 1<sup>st</sup> hearing was held on 15<sup>th</sup> March'2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh and the Appellant Shri Abang Yango were present during the hearing.
