ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P. O/o Deputy Commissioner Khonsa, Tirap District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 8/11/2021 regarding Details of expenditure of Deputy Commissioner Untied fund.

Whereas, the 1st hearing was held on 22nd March'2022 at 1030hrs as scheduled. Shri Makba Nasi, PIO-cum-PTA(PR), Govt. of A.P. O/o Deputy Commissioner Khonsa, Tirap District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that the information were ready and the Appellant was intimated vide letter no. TDP-127/UF/2021-22/3160-68 Dated Khonsa, the 15th Mar'2022 to collect information after making payment through Treasury Challan but the Appellant did not respond. The Appellant informed that he has not received any intimation.

Whereas, the Commission directed the PIO to furnish all the information free of cost to the Appellant as the PIO has delayed in responding the RTI Application. The Commission also asked the Appellant to receive the information from the office of the PIO and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 31st May' 2022 at 1030 hrs.

Therefore, The Public Information Officer, Govt. of A.P. O/o Deputy Commissioner Khonsa, Tirap District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
