ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P. O/o Deputy Commissioner Koloriang, Kurung Kumey District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 8/11/2021 regarding Details of expenditure of Deputy Commissioner Untied fund.

Whereas, the 1st hearing was held on 22nd March'2022 at 1030hrs as scheduled. Shri Aby Taba, The PIO-cum-CO, O/o Deputy Commissioner Koloriang, Kurung Kumey District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The appellant informed the Commission that the PIO has not furnished any information as sought by him. The PIO informed that due to shortage of staff; all Circle Officers being posted in the outpost; shifting of office to newly constructed Mini Secretariat and due to changes in the charge of PIO the information could not be furnished to the Appellant in time. However, the PIO appealed the Commission to give some time to furnish information to the Appellant.

Whereas, the Commission after hearing both the parties directed the PIO to furnish all the available information to the Appellant free of cost. The Commission asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 31st May' 2022 at 10:30 hrs.
