ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P. O/o Deputy Commissioner Changlang, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 8/11/2021 regarding Details of expenditure of Deputy Commissioner Untied fund.

Whereas, the 1st hearing was held on 22nd March' 2022 at 1030hrs as scheduled. Shri S. Timba, the PIO-cum- District Planning Officer O/o Deputy Commissioner Changlang, Changlang District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that the information were kept ready and intimation was served to the Appellant asking them to receive the information after depositing the fees for the same through Treasury challan but the Appellant did not respond to it.
