ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-CUM-EE(PWD), Govt. of A.P. Jamin Division, Kra Dadi District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding Expenditure and implementation of scheme and fund sanction under, SADA, SIDF, RE, Maintenance (State Annual Development Agenda) 2014 to 2021.

Whereas, the 1st hearing was held on 22nd March' 2022 at 1030hrs as scheduled. The PIO-CUM-EE(PWD), Govt. of A.P. Jamin Division, Kra Dadi District, Arunachal Pradesh was found absent during the hearing. However, Shri Risso Johnny, APIO-cum-AE, Palin Division PWD represented the PIO. The Appellant Shri Abang Yango was present. The Appellant informed the Commission that the PIO has not furnished any information as sought by him. The APIO informed that the Appellant has sought information from 2014 to 2021, so due to recent bifurcation of the division all the information as sought by the Appellant is not available in his division.

Whereas, the Commission after hearing both the parties directed the PIO to furnish all the available information of his division to the Appellant. The Commission asked the Appellant to seek other relevant information from the concern division. The APIO and the Appellant agreed to comply with the directions of the Commission. The Commission also asked the Appellant to receive the information from the PIO and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 31st May '2022 at 10:30 hrs.

Therefore, The PIO-CUM-EE(PWD), Govt. of A.P. Jamin Division, Kra Dadi District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
