Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/11/2021 regarding Expenditure and implementation of schemes and fund sanction under SADA, SIDF, RE, Maintenance (State Annual Development Agenda) 2014-2021.

Whereas, the 1<sup>st</sup> hearing was held on 5<sup>th</sup> April, 2022 at 1030hrs as scheduled. The PIO-cum-EE (PWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh was found absent during the hearing. The Appellant, Shri Abang Yangfo was present. The Appellant informed the Commission that the PIO has not furnished any information as sought in the From-A, Dated 15/11/2021.
