ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Ziro Division, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 13/10/2021 regarding C/O Mini Secretariat Building at Ziro. L/Subansiri District.

Whereas, the 1st hearing was held on 8th February'2022 at 1030hrs as scheduled. Shri N.L.Togu, the PIO-cum-EE(PWED) Ziro Division, Govt. of A.P, Lower Subansiri District and the Appellant Shri Tania June were present during the hearing. The PIO informed the Commission that his office has not received any application in Form-A of the Appellant and not known what information the Appellant was seeking for. The Appellant informed that he has sent the Application by post.

Whereas, the Commission supplied a Xerox copy of the From-A dated 18/10/21 submitted by the Appellant and directed the PIO to furnish all the information as sought by the Appellant in the application. The Commission also asked the Appellant to receive the information and convey his observations as to whether he is satisfied with the infomations furnished by the PIO in the next date of hearing.

Whereas, the 2nd hearing was held on 19th April'2022 at 1030hrs as scheduled. Shri N.L.Togu, the PIO-cum-EE(PWED) Ziro Division, Govt. of A.P, Lower Subansiri District was found absent during the hearing. However, Shri Koj Tajo, ASW (PWD) Ziro Division represented the PIO. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that he has received some information a day before the hearing, i.e. on 18th April, 2022. So, the Appellant appealed the Commission to give reasonable opportunity to go through the information furnished by the PIO.

Whereas, the Commission giving reasonable opportunity asked the Appellant to go through the information and convey his satisfaction or dissatisfaction before the next date of hearing.

The next date of hearing is fixed on 24th May' 2022 at 10:30 hrs.

Therefore, Shri N.L.Togu, the PIO-cum-EE(PWD), Ziro Division, Govt. of A.P., Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
