ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(UD), Khonsa, Govt. of A.P., Tirap District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 13/10/2021 regarding fund sanction under SIDF, SADA, RE supply and maintenance for the District Tirap for development activities.

Whereas, the 1st hearing was held on 8th February'2022 at 1030hrs as scheduled. Shri Tai Sangkio, The PIO-cum-EE(UD), Khonsa, Govt. of A.P., Tirap District, Arunachal Pradesh and the Appellant Shri Tania June were present during the hearing. The PIO informed the Commission that the information sought for by the Appellant were kept ready within the stipulated time and intimation was served to the Appellant to deposit the amount through Treasury challan being the cost of duplicating charge of the informations and collect the same but the Appellant did not turn up to collect the information. The Appellant informed that he has not received any such intimation from the PIO. The PIO also could not furnish any proof to the Commission during the hearing.

Whereas, the Commission giving reasonable opportunity, directed the PIO to bring the proof of serving intimation to the Appellant in the next date of hearing. The Commission made it clear that if the PIO furnishes proof of the intimation and if the intimation made is within the prescribed period then the Appellant has to pay charges for the information and in case the PIO cannot produce the authentic evidence, the has to furnish all the information free of cost to the appellant.

Whereas, the 2nd hearing was held on 19th April'2022 at 1030hrs as scheduled. Shri Tai Sangkio, the PIO-cum-EE(UD), Khonsa, Govt. of A.P.,Tirap District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO, as directed in the last hearing brought the evidences during the hearing and placed it before the Commission. The PIO also brought the information in the court and handed it over to the Appellant with a request to pay fee for the same through treasury challan. The Appellant received the information.

Whereas, the Commission after going through the evidences found that the PIO has acted diligently in intimating the Appellant to collect the information. So, the Commission asked the Appellant to pay the fee for the information through treasury Challan. The Appellant agreed to comply with the direction of the Commission. The Commission giving reasonable opportunity to the Appellant to go through the information decided to have one more hearing.

The next date of hearing is fixed on 24th May'2022 at 10:30 hrs.

Therefore, **Shri Tai Sangkio, the PIO-cum-EE(UD), Khonsa, Govt. of A.P.,Tirap District, Arunachal Pradesh** is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
