SHOW CAUSE NOTICE


WHEREAS, Shri Mamu Sono filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 28.01.2022 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-156/2022, wherein, alleging against you that you have failed to furnish information sought by the Appellant under Form-A of his application dated 24.11.2021 relating the matter as quoted in Form-A, application.

AND WHEREAS, you, being PIO-Cum-Dy. Director, ICDS, Seppa, District: East Kameng, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

AND WHEREAS, date of hearing of the Appeal was intimated to you in advance but you were found absent during hearings in following date 14/03/2022, 20/06/2022, 05/09/2022 and 26/09/2022 and also you failed to furnish complete informations to the Appellant as sought in his Form-A till the 6th hearing. The Commission viewed seriously on consecutive absence of the PIO during the hearing and found liable for imposing reasonable penalty of your negligence in furnishing of the complete informations as sought by the Appellant.

NOW THEREFORE, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the replies to Show-Cause Notice issued against you on or before 7th November 2022 at 1000 hrs to show cause as to why you should not be imposed a reasonable penalty as provided in Section 20 (1) of the RTI Act for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.
