**ORDER**

The appellant vide his RTI dated 26.11.2021 sought information on 16 points as contained therein.

The PIO did not provide any reply to the appellant in response to the present RTI application. The appellant then filled a first appeal. The FAA also did not response to the appeal.

The appellant, therefore, filed a second appeal before the commission with a request to provide complete information.

The appeal is heard today. The appellant is absent. Dr. T.S. Miji (VO) has appeared before the commission. The PIO vide his letter dated 23.03.2022 has authorised Dr. T.S. Miji Veterinary Officer to attend the hearing on his behalf.

I have heard Dr.T.S. Miji, Veterinary Officer who is appearing on behalf of the PIO. During course of hearing Dr.T.S.Miji (VO) has submitted that present RTI application was received by the PIO on 10.12.2021 and reply to the RTI application was furnished to the appellant on 27.12.2021. He has stated that the PIO vide letter dated 10.12.2021 had informed the appellant to collect the required information after depositing Rupees 1300/-, but no response was received from the appellant. He has further informed that

the PIO on 04.02.2022 had issued another letter to the appellant which was also not responded. The appellant is not present to contest the submission of Dr.T.S.Miji.

Upon perusal records it appears that the PIO has dealt with the RTI application responsively and in time bound manner. However, the commission considers that relief cannot be allowed to the appellant and justice is not possible without hearing.

The hearing is therefore adjourned to 29.04.2022 at 10:30 hrs. to allow an opportunity of hearing.

The PIO is also directed to send the required information by registered post to the appellant.

Both the PIO and appellant are directed to be present during next hearing on the above mentioned date and time, failing which matter shall be decided ex-Parte.
