ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from **Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh** for non-furnishing of information by **The PIO-cum-District Horticulture officer, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh** as sought by the Appellant under section 6(1) of RTI Act, 2005 on 26/11/2021 regarding **implementation of Horticulture development schemes (2018 to 2021)**.

Whereas, the 1st hearing was held on 5th April, 2022 at 1030hrs as scheduled. Shri Komri Murtem, the PIO-cum-District Horticulture officer, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that all the information as sought by the Appellant at From A Dated 26/11/2021 were kept ready to be furnished but the Appellant did not turn-up to collect the information. The Appellant informed that the PIO did not give any intimation to collect the information. The PIO also agreed that he did not serve any intimation letter to the Appellant.

Whereas, the Commission after hearing both the parties directed the PIO to furnish all the available information as sought in the Form-A Dated **26/11/2021** free of cost to the Appellant. The PIO agreed to comply with the directions of the Commission. The commission also asked the Appellant to collect information from the office of the PIO and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 17th May' 2022 at 1030 hrs.

Therefore, the PIO-cum-District Horticulture officer, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
