R/Sir,

With humble regard it is to state that on 23.02.2022 vide letter no: PRWD/RTI/19-20/161-62 furnished the Contractor Certificate of M/s Agam Construction. The same Contractor Certificate has been used by the M/s Agam Construction to take part in tender process of C/o Infrastructure Development of 5th IRBN at Pasighat. Later the work has been awarded to M/s Agam Construction.


Whereas regarding Completion Certificate of M/s Agam Construction, the concern APIO of the O/O Executive Engineer, RWD Pasighat Division stated that the information/document are **"not available at Division Office (RWD Pasighat Division) as tender was conducted at SE Office Pasighat"**.

It is pertinent to re-mention that on 09.04.2021, RTI in Form-A has been filed at O/O EE, RWD Pasighat Division. They invoked section 8 of RTI Act, 2005 for not furnishing Contractor Certificate & Completion Certificate. Subsequently, 1st and 2nd Appeal has been filed. Hearings have been also conducted before your hon'ble courts also. But on 23.02.2022 vide letter no: PRWD/RTI/19-20/161-62 stated that the Tender Process has been conducted at SE Office. After wasting 10 precious months, the APIO said that the tender process have been conducted at SE Office at Pasighat. It look like that, the O/O EE RWD Pasighat Division had helped the contractor by delayed in furnishing of RTI information/documents to hold me in taking appropriate legal action against the Contractor for his forgery. The APIO advised me verbally to file a RTI at SE RWD Pasighat Circle to get the remaining information/documents regarding Completion Certificates. Officials of O/O EE RWD Pasighat Division very well known that the tender was conducted at SE RWD pasighat Circle. This is their intentional tactics to waste my time once again.

Therefore, my humble prayer before you to direct the EE-cum-PIO, RWD Pasighat Division to collect the Completion Certificate of M/s Agam Construction Certificate from the O/O SE RWD Pasighat Circle and furnish the same to me. This will help me a lot in initiating appropriate legal action against the firm in appropriate court.



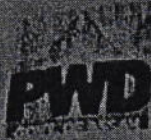
