Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, President (AAVS) & Shri Abang Yangfo, AGS(AAVS), C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Division Yazali, Ziro II, Lower Subansiri District, Arunachal Pradesh as sought for, by the Appellant under section 6(1) of RTI Act, 2005 on 18/10/2021 regarding C/o Road from 20th KM point (New Loth) on Ziro Daporijo B.R.T.F. Road to Chambang (74 KM).

Whereas, the 1st hearing was held on 8th February'2022 at 1030hrs as scheduled. Shri Tania June, Appellant was present but the PIO cum EE PWD, Lower Subansiri District, Ziro was not present. Shri Nich Jacob, UDC, who represented the PIO informed that the PIO is not keeping well. Shri Nich Jacob, explained the reasons for not being able to furnish the required information in time. He said that he was infected with Corona virus last year during the time this information was sought by the Appellant.

Shri Nich Jacob expressed his inability to prepare and find out such voluminous information right from 2005 to 2021, which is practically not possible due to limited manpower and which would involve find for printing the copies and is also time taking which may hamper the day to day office works of the Deptt.

The Commission asked to the Appellant to accept the very specific information in the public interest and directed the PIO to furnish the specific information free of cost.

The next date of hearing is fixed on 19.04.2022 at 10:30 hrs.

Therefore, **PIO-cum- EE(PWD)**, **Govt. of A.P.**, **Division Yazali**, **Ziro II**, **Lower Subansiri District**, **Arunachal Pradesh**, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
