SUMMON NOTICE

Whereas, Shri Takar Goi filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 29.04.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal **APICs No.-185/186/187/2021**, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 25.03.2021 relating the matter to furnish the certified True Copies (CTCs) of information/documents in respect of the said work.

Whereas, you being PIO of the WRD Division, Pasighat, East Siang Distt., Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, on last hearing i.e. on 25th October, 2021 you are intimated the next date of hearing but you were found absent on the day of hearing i.e. on 24th January, 2022 and intimating through whatups that due to infection of Covid-19 you could not able to attend the hearing of the appeal.

Therefore, the Commission directed you to appear before the Commission in person if your health condition improves, otherwise you have to submit your detail medical records of your treatment to the Commission during the next date of hearing alongwith the informations sought by the appellant, failing which Section 18 (3) of the RTI Act, 2005 shall be invoked against the PIO. Next date of hearing fixed on 14th February, 2022 at 10:00 hrs.
