**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been filed by Sri Libi Marde, OBT House, NITI VIHAR, Ward No. 08, IMC/D-99, Itanagar, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE & WS),Daporijo Division, Upper Subansiri District, Arunachal Pradesh as requested by the Appellant under section 6(1) of RTI Act, 2005 on 27/10/2021 regarding National Rural drinking water Program (NRDWP), Jal Jeevan Mission (JJM) and SADA.

Whereas, the 1<sup>st</sup> hearing was held on 1<sup>st</sup> March'2022 at 1030hrs as scheduled. Shri D. Tayo, the PIO-cum-EE(PHE & WS),Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Libi marde were present during the hearing. The Appellant informed the Commission that the PIO has not furnished any information. The PIO informed the Commission with evidences that the information sought by the Appellant is very voluminous so intimated the Appellant to seek specific information but the Appellant did not respond to it. So information could not be furnished. However, the PIO informed that information can be furnished if sufficient time is granted to him to supply the information.

Whereas, the Commission asked the Appellant to be specific in seeking information from the public authority. The Commission directed the PIO to sort out the specific information and furnish the same to the Appellant before the next date of hearing. The Commission giving reasonable time and opportunity to the PIO decided to fix next date of hearing.

Whereas, the 2<sup>nd</sup> hearing was held on 24<sup>th</sup> May'2022 at 1030hrs as scheduled. Dr. D. Tago, the PIO-cum-EE(PHE & WS),Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Libi Marde were present during the hearing. The PIO brought the information during the hearing. The Appellant received the information and informed the Commission that the PIO has not furnished detail index of the information so furnished and also appealed the Commission to give some reasonable time to go through the information.

Whereas, the Commission directed the PIO to give the detail index of the information furnished to the Appellant. The PIO agreed to comply with the direction of the Commission. The Commission asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

**Whereas, the 3<sup>rd</sup> hearing was held on 7<sup>th</sup> June, 2022 at 1030hrs as scheduled.** Shri. D. Tago, the PIO-cum-EE(PHE & WS), Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Libi Marde were present during the hearing. The Appellant informed that the information furnished by the PIO are incomplete. The PIO informed that the information sought are voluminous as well some information sought for are not available in his office.

**Whereas,** the Commission after hearing the arguments of both the parties and going through the information sought by the Appellant in the Form-A Dated 27/10/2021, the Commission sorted out a list of information to be furnished by the PIO to the Appellant.

**The list are as follows (Sl.no. are as per the Form-A Dated 27/10/2021): -**

XII. The PIO to give in writing regarding "list of project/scheme subsumed to Jal Jeevan Mission.

XIII. Schedule of Rates (SoR) (to be furnished)

**2. Regarding Jal Jeevan Mission (JJM) for the financial 2019 to 2022**

- Only work list and copies of sanction orders to be furnished.

**3. Jal Jeevan Mission (JJM) under 14<sup>th</sup> Finance Commission, 2015 to 2021**

- The PIO shall give in writing to the Appellant regarding the 14<sup>th</sup> Finance Commission.

- List of schemes to be furnished.

**5. Annual Work account to be furnished from 2010 to 2021**

Whereas, the Commission U/S 2(j)(i) of the RTI Act 2005 directed the PIO to allow the Appellant for inspection of records which are unable to furnish. As per the provision of Govt. Notification No. AR-47/2014 Dated the 13<sup>th</sup> November'2014 the Commission allows the Appellant to inspect documents/records free of cost for first hour and for the subsequent each 15 minutes the Appellant is directed to deposit the total amount into the Head of Account "0070" other Administrative Services through Treasury Challan. The Commission also asked the Appellant to receive the information and convey his satisfaction in the next date of hearing.

The next date of hearing is fixed on 2<sup>nd</sup> August, 2022 at 10:30 hrs.

Therefore, The PIO-cum-EE(PHE & WS),Daporijo Division, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
