ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Sri Libi Marde, OBT House, NITI VIHAR, Ward No. 08, IMC/D-99, Itanagar, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE & WS), Daporijo Division, Upper Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 27/10/2021 regarding National Rural drinking water Program (NRDWP), Jal Jeevan Mission (JJM) and SADA.

Whereas, the 1st hearing was held on 1st March'2022 at 1030hrs as scheduled. Shri D. Tayo, the PIO-cum-EE(PHE & WS), Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Libi marde were present during the hearing. The Appellant informed the Commission that the PIO has not furnished any information. The PIO informed the Commission with evidences that the information sought by the Appellant is very voluminous so he had written to the Appellant to seek specific information but the Appellant did not respond to it. So information could not be furnished. However, the PIO informed that information can be furnished if sufficient time is granted to him to supply the information.

Whereas, the Commission asked the Appellant to be specific in seeking information from the public authority. The Commission directed the PIO to sort out the specific information with the Appellant and furnish the same to the Appellant before the next date of hearing. The Commission giving reasonable time and opportunity to the PIO decided to fix next date of hearing.

Whereas, the 2nd hearing was held on 24th May'2022 at 1030hrs as scheduled. Dr. D. Tago, the PIO-cum-EE(PHE & WS), Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Libi Marde were present during the hearing. The PIO brought the information during the hearing. The Appellant received the information and informed the Commission that the PIO has not furnished detail index of the information furnished and also appealed the Commission to give some reasonable time to go through the information.

Whereas, the Commission directed the PIO to give the detail index of the information furnished to the Appellant. The PIO agreed to comply with the direction of the Commission. The Commission asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 7th June, 2022 at 10:30 hrs.

Therefore, The PIO-cum-EE(PHE & WS), Daporijo Division, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
