**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(UD), Govt. of A.P., Ziro, Deptt. Of Urban Development, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 18/10/2021 regarding SADA, SIDF, RE (state Annual Development Agenda) 2014 to 2021.

Whereas, the 1<sup>st</sup> hearing was held on 8<sup>th</sup> February'2022 at 1030hrs as scheduled. Shri NichYacob, The PIO-cum-EE(UD), Govt. of A.P., Ziro, Deptt. Of Urban Development, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Tania June were present during the hearing. The PIO informed the Commission that the information sought by the Appellant is voluminous, it consists of many of projects sanctioned during the 2016-2021 under SADA, SIDF, RE and PMGSY. It is extremely difficult to furnish such voluminous information. The PIO appealed the Commission to ask the Appellant to seek specific information so that the information can be furnished within the time period as prescribed.

Whereas, the Commission directed the PIO and asked the Appellant to sit across the table and sort out the specific information as required. The Commission also asked the Appellant to receive the specific information as require and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held on 19<sup>th</sup> April'2022 at 1030hrs as scheduled. Shri Nich Yacob, The PIO-cum-EE(UD), Govt. of A.P., Ziro, Deptt. of Urban Development, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The Appellant informed the Commission that the PIO has furnished the information but need time to go through. So, appealed the Commission to give reasonable time to go through the information.

Whereas, the Commission giving reasonable opportunity asked the Appellant to go through the information and convey his satisfaction or dissatisfaction before the next date of hearing.

The next date of hearing is fixed on 24<sup>th</sup> May'2022 at 1030 hrs.

Therefore, Shri Nich Yacob, The PIO-cum-EE(UD), Govt. of A.P., Ziro, Deptt. Of Urban Development, Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.


