ORDER

The Appellant vide his RTI application dated 29th April, 2021 sought information 14 points as contained therein.

The PIO did not provide any reply to the Appellant in response to the present RTI application. The Appellant then filed a First Appeal. The First Appellate Authority also did not response to the appeal.

The Appellant, therefore, filed a second appeal before the commission with a request to provide complete information.

Hearing of the second appeal was taken up on 12th November, 2021.

The appellant, who was present during the hearing, informed the commission that the PIO had furnished the information sought in point No. (1),(2),(3),(5),(7),(8),(9),(10),(11),(12),(13) and (14) of the RTI application and he had refused to furnish the information sought in point No.(4),(6) and (15). The PIO had, though not present, submitted a letter dated 11.11.2021 wherein he has requested for postponement of the hearing. The commission considered the request of the PIO and accordingly, hearing was postponed till 17.11.2021.

Hearing of the appeal is taken up today on 17.11. 2021.

The Appellant is present. The PIO is again absent. The Appellant has informed the commission that no response has been received from the PIO. The commission after hearing the appellant and perusal of records, directs the PIO to furnish information within 2 weeks from today with an intimation to the commission, failing which action under section 20 (1) shall be initiated by the commission. The appellant is also directed to furnish the copy of this order to the PIO.

Accordingly, Case is adjourned to 25th February, 2022 at 10:30 hrs.

The PIO shall appear before the commission on the above mentioned date and time.
