ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding implementation and Expenditure of schemes and Fund Sanctioned under, SADA, SIDF, RE, Supply, BA, Renovations, Central sponsor scheme, state sponsor scheme. (State Annual Development Agenda) 2014 to 2021.

Whereas, the 1st hearing was held on 5th April, 2022 at 1030hrs as scheduled. Shri Bamang Tasung, the PIO-cum-EE(PHE), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The PIO informed the Commission that the information were kept ready and the Appellant were intimated to deposit fee for the information through Treasury Challan and collect the same but the Appellant did not turn-up. The Appellant informed that he has not received any intimation as stated by the PIO. The PIO submitted a copy of the intimation letter and postal evidence to the Commission during the hearing.

Whereas, the Commission after hearing both the parties and going through the evidences produced by the PIO, asked the Appellant to deposit the requisite fee and collect the information from the office of the PIO. The appellant agreed to comply with the commission's direction. The Commission also asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held on 17th May' 2022 at 1030hrs as scheduled. Shri Bamang Tasung, the PIO-cum-EE(PHE), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh was found absent during the hearing. However, Shri Tayia Doni, APIO-cum-AE(PHE) Khonsa Division represented the PIO. The Appellant Shri Abang Yangfo was present. The APIO informed the Commission that information are ready to be furnished but the Appellant did not turn up. The Appellant requested the APIO to send only the Sanction Orders of the Schemes as sought in the Form-A Dated 30/11/2021 in his Whatsapp no.

Whereas, the Commission directed the APIO to furnish the Sanctions orders as appealed by the Appellant. The APIO agreed to comply with the direction of the Commission. The Commission asked the Appellant to convey his satisfaction or dissatisfaction in the next date of hearing. .

The next date of hearing is fixed on 28th June' 2022 at 1030 hrs.

Therefore, the PIO-cum-EE(PHE), Govt. of A.P., Khonsa Division, Tirap District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
