ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding implementation and Expenditure of schemes and Fund Sanctioned under, SADA, SIDF, RE, Supply, BA, Renovations, Central sponsor scheme, state sponsor scheme. (State Annual Development Agenda) 2014 to 2021.

Whereas, the rescheduled 1st hearing was held on 7th June, 2022 at 1030hrs. The PIO-cum-EE(PHE), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh was found absent during the hearing. The appellant Shri Tania June was present. The Appellant informed the Commission that he has not received any information from the PIO.

Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty without any prior information. The Commission giving reasonable opportunity, directs the PIO to attend the court in the next date of hearing. Failing which the Commission shall be compelled to impose penalty against the PIO U/S 20(1) of the RTI Act 2005.

Whereas, the rescheduled 2nd hearing was held on 5th July' 2022 at 1030hrs. Shri Tani Taki, the PIO-cum-EE(PHE), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh was present during the hearing. The Appellants were absent. The PIO informed the Commission that he had received the Form-A Dated 30/11/2021 on 15/12/2022. Vide letter No. PHED/CHG/RTI/VOL-II/2020-21/2000 Dtd Changlang, the 23/12/2021 had requested the Appellant to deposit Rs. 50/- through Treasury Challan in the H/A "0070-other Admin charges" and resubmit the same along with a copy of Treasury Challan. The letter was sent through postal on 28/12/2021 but did not receive any reply from the Appellant. Again, vide Memo No. PHED/CHG/RTI/VOL-II/2020-21/2880-82 Dtd Changlang, the 03/03/2022 a detail list of information and its fees amounting to Rs. 64, 73,930/- (Rupees sixty four lakhs seventy three thousand nine hundred thirty) only was intimated to the Appellant for assurance of payment, but the Appellant did not respond to it.

Whereas, the Commission giving reasonable opportunity to the Appellant and also to hear from the Appellant side decided to fix next date of hearing.

The next date of hearing is fixed on 9th August' 2022 at 1030 hrs.

Therefore, the PIO-cum-EE(PHE), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
