## **ORDER**

The Appellant vide his RTI application dated 22<sup>nd</sup> February, 2021 sought information on 09 points.

The PIO did not provide reply to the Appellant in response to the present RTI application. The Appellant then filed a First Appeal. The First Appellate Authority also did not response to the appeal.

The Appellant, therefore, filed a second appeal before the commission with a request to provide complete information.

Hearing of the second appeal was held on 12<sup>th</sup> November, 2021.

Both the PIO and the Appellant were not absent during the hearing. However, a letter was received from the appellant requesting the commission to postpone the hearing. As of the PIO and the appellant were absent, hearing was postponed till 17.11.2021.

Hearing of the appeal is taken up today on 17.11.2021.

The Appellant is present. The PIO is again absent. During the course of hearing the appellant has informed that the PIO has not furnished the information to him.

Upon the perusal of records, it appears that RTI application was received by the PIO on 23.02.2021, but he did not response to the RTI application. Even no formal hearing of First Appeal conducted by the First Appellate Authority. After considering the submission made by the appellant and perusal records, the commission directs the PIO to furnish complete information to the appellant within two weeks from the receipt of this order, failing which action under section 20 (1) of the RTI Act, 2005, shall be initiated by the commission. The appellant is directed to serve the copy of this order to the PIO. Next hearing is fixed on 25.02.2022 at 1030 hrs.

The PIO was directed to appear before the commission on the afore mention date and time.
