ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding implementation and Expenditure of schemes and Fund Sanctioned under, SADA, SIDF, RE, Supply, BA, Renovations, Central sponsor scheme, state sponsor scheme. (State Annual Development Agenda) 2014 to 2021.

Whereas, the rescheduled 1st hearing was held on 7th June, 2022 at 1030hrs. The PIO-cum-EE(PHE), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh was found absent during the hearing. The appellant Shri Tania June was present. The Appellant informed the Commission that he has not received any information from the PIO.

Whereas, the Commission viewed seriously the absenting of the PIO from performing the statutory duty without any prior information.
