**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(Power), Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding implementation and Expenditure of schemes and Fund Sanctioned under, SADA, SIDF, RE, Supply, BA, Renovations, Central sponsor scheme, state sponsor scheme. (State Annual Development Agenda) 2014 to 2021.

Whereas, the rescheduled 1<sup>st</sup> hearing was held on 7<sup>th</sup> June, 2022 at 1030hrs. Er. J. Dulom, the PIO-cum-EE(Power), Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Tania June were present during the hearing. The PIO informed the Commission that the information were kept ready to be furnished but the Appellant did not turn up to receive the information, so PIO handed over the information to the Appellant in the court. The Appellant received the information from the PIO and appealed the Commission to give time to go through the same.

Whereas, the Commission giving reasonable opportunity to the Appellant to go through the information, asked the Appellant to go through the same and convey his satisfaction or satisfaction before the next date of hearing.

Whereas, the 2<sup>nd</sup> hearing was held on 5<sup>th</sup> July' 2022 at 1030hrs. Er. J. Dulom, the PIO-cum-EE(Power), Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh and the Appellants were found absent during the hearing. The PIO had already furnished the information to the Appellant and the Commission had given opportunity to the Appellant to go through the information and convey his satisfaction or dissatisfaction. Since, the Appellant was absent the Commission could not ascertain the satisfaction of the Appellant.

Whereas, the Commission giving final opportunity to the Appellant to convey his satisfaction or dissatisfaction decided to fix next date of hearing. In case of failing to appear in the next date of hearing the Commission shall disposed of the case with the presumption that the Appellant is satisfied with information furnished by the PIO.

**The next date of hearing is fixed on 23<sup>rd</sup> August' 2022 at 1030 hrs.**

Therefore, the PIO-cum-EE(Power), Govt. of A.P., Daporijo Division, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
